

TPM's Fab-boo-lous Pet Costume Contest RULES AND REGULATIONS

1. *Sponsor & Time Period.* TAWANI Property Management LLC (the “*Sponsor*”) with a principal business address of 104 S Michigan Ave, Ste 1025, Chicago, IL 60603 is the sponsor of this Enter to win TPM’s Fab-boo-lous Pet Costume Contest (the “*Contest*”), which commences at 12:00 a.m. on October 7, 2024 and concludes at 11:59 p.m. on October 31, 2024 (the “*Contest Period*”).

2. *Eligibility.* The Contest is open to residents of Chicago, Illinois, who at the time of entry are at least 18 years old and a tenant of property owned and managed by Sponsor. No Entrant has automatically won. The owners, officers, employees and directors of Sponsor, as well as immediate family members of any of the foregoing, are not eligible. Entries from any other jurisdiction will be disqualified.

3. *How to Enter.* To enter, submit one (1) photograph of your pet wearing a Halloween costume using the form at <https://www.tawanipropertymanagement.com/halloween-pet-costume-contest/> (the “*Entry Photo*”). Entrant must be a registered Facebook user and must submit the Entry Photo with Entrant’s name, address, city, email address, and pet’s name for the entry to be eligible as a Contest entrant (“*Entrant*”). All entries must be received by October 25, 2024 to officially qualify for the Contest. Limit of one (1) entry per person. Sponsor will upload a maximum of five (5) Entry Photos to Sponsor’s Facebook page, www.facebook.com/tawanipropmgmt. If more than five (5) Entry Photos are submitted, Sponsor reserves the right to select five (5) Entry Photos, as determined by Sponsor in its sole discretion.

Sponsor is not responsible for lost, late, delayed, mutilated, misdirected, illegible, incomplete or postage due mail or entries, or any computer, internet, printing, typographical, administrative or technological errors or failures associated with the Contest. Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process or the operation of the Contest or violates these Rules. Entries are subject to verification by Sponsor.
